



## **“Sustainability. Go Green For A Better World To Live In.” (Promotion)**

### **Lendlease Plus Member Exclusive: Green For The Win Spinwheel**

- 1.1 Shoppers who spend a minimum of **S\$100** at any Stores in Jem, within a maximum of three (3) same-day receipts with each receipt meeting the minimum spend of S\$10, from 5 – 28 April 2019, are eligible for one (1) chance to participate in the digital sure-win lucky spin to win Lendlease E-Vouchers or Retailers' Gift Vouchers / Products.

## 2. Terrific Terrarium Workshop
