

Jem 'Do Yourself A Favour' Facebook Contest

4 – 28 June 2015

Terms & Conditions

1. The contest described in this document ("Contest") is organised and promoted by Lend Lease Retail Investments 3 Pte Ltd of 6 Shenton Way, #23-08, OUE Downtown II, Singapore 068809 ("Jem"), a subsidiary of Lend Lease Corporation Ltd (ABN 32 00 226 226) ("Lend Lease")
2. By participating in the Contest, participants agree to be bound by the terms and conditions of the Contest ("Terms") which at the date of publication are set out below. Jem reserves the right to change the Terms (including the dates of the Contest and the prizes or their value) at its sole discretion without notice.
3. Except as other specified in these Terms, Jem's decision on all matters relating to the Contest is final, conclusive and binding on all participants and no correspondence will be entertained.

The Contest

4. Jem has organised a Facebook contest (Do Yourself A Favour). From 4th to 19th June 2015, Jem will post 3 products images and participants will have to choose a product and state why they like it on Jem Facebook page comment box.
5. There will be four (4) posts with three (3) images (on each post) on these following dates; 4th, 9th, 14th and 19th June 2015.
6. All entries must be completed by 11.59pm on 24 June 2015. The official time is Singapore Facebook time. Any entry posted after the cut-off time will not be considered.
7. There will be a total of eight (8) winners who will each receive \$500 worth of Jem Gift Vouchers. Two (2) winners from each post entry.
8. A maximum of one (1) entry per person is allowed per Facebook post. In the event that two or more answers/comments submitted by the same participant only the last submission will be considered valid.
9. Any entry that is made on behalf of an entrant by a third party will be invalid. All entries must be submitted by a person with his/her own Facebook account and any automated entries, fraudulent entries or entries by persons using an alias shall be invalid.
10. The winners will be announced on <https://www.facebook.com/JemSingapore> on 28 June 2015.
11. Winners must provide their Full Name (as stated in NRIC/FIN), NRIC/FIN number and contact number and email address via Jem Facebook private message.
12. Winners must present their NRIC/FIN identification card for verification upon collection of prizes. Prize(s) must be collected by the Winner in person, with original personal photo identification (e.g. NRIC/FIN identification card) for verification, no later than 26 July 2015. Uncollected Prizes will be forfeited.
13. Prizes are not transferrable and not redeemable for cash, credit or otherwise. Jem's Management reserves the rights to substitute any, or all, of the prizes to be awarded to the winners of the contest without prior notice. Jem's Management also reserves the right to amend the list of winners should the original winners be uncontactable after three attempts to establish contact via phone and/or Facebook.

14. To the extent permitted by law, by participating in the Contest each participants releases Lend Lease, its subsidiaries, agents and assigns from, and indemnifies the same against, any liability for loss, cost, expense or damage to person or property suffered or incurred arising out of, or in connection with, the Contest, or the collection or use of any prize.
15. Participants warrant and agree that their Entry Content (in whole or in part):
 - a. have not been published previously;
 - b. do not and will not infringe any third party rights (including intellectual property rights or rights of privacy, publicity or confidentiality);
 - c. are not unlawful, fraudulent, defamatory, obscene, profane, derogatory, pornographic, sexually inappropriate, politically incorrect, violent, abusive, insulting, scandalous, inflammatory, harassing, threatening, racist, ageist, sexist, objectionable with respect to religion, origin or gender, not suitable for children under 15, or otherwise unsuitable for publication or objectionable; will not contain viruses or cause injury or harm to any person or entity.
16. This competition is a game of skill, and chance plays no part in determining the prize winners. All valid entries received during the Submission Period will be judged by Jem based on their originality, creativity, caption, and whether the entry complies with these terms and conditions.
17. Jem reserves the right to verify the validity of all entries and reserves the right to disqualify any entrant:
 - a. who tampers with the submission or voting process;
 - b. who submits an entry that is not in accordance with these terms and conditions;
 - c. who has, in the opinion of Jem, engaged in any unlawful or other improper conduct which jeopardises, or may jeopardise, the fair and proper conduct of the competition; and/or
 - d. who has engaged in conduct in entering the competition which is unlawful, fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the competition and/or Jem.
18. Jem reserves the right to disqualify an entrant or the winner if the Jem becomes aware that the entrant or winner and/or the winner's entry is of a type described in this section or is otherwise not in accordance with these terms and conditions. Jem's legal rights to recover damages or other compensation from such disqualified persons are reserved.

Eligibility to Enter

19. Participation in the Contest is open to all citizens and residents of Singapore above sixteen (16) years of age as of 4 June 2015 except:
 - a. employees of Lend Lease, its subsidiaries, public relations and advertising agencies and tenants of Jem; and
 - b. the immediate families of such employees. Immediate family members include spouses, children, parents, parents-in-law and siblings.
20. Acceptance of a prize constitutes permission for Lend Lease to use the winner's name and/or likeness, and their submitted photo for advertising purposes without further notice or compensation, unless prohibited by law.

21. Jem reserves the right to disqualify any entry submitted by a non-eligible participant and in each case (if applicable) require that person to reimburse the value of any prize awarded to them.

Personal Information

22. Lend Lease may:
 - a. disqualify any entry containing false or incomplete information; and
 - b. disclose participants personal information to the relevant authorities and publish the names of winners as required by law.
23. Personal information you provide in registering to participate in the Contest, or otherwise deal with Jem, may be collected and used for several purposes including, but not limited to, analytical purposes, sending you occasional updates for special promotions, announcements & important updates from Jem (through any mode from time to time, which shall include without limitation mailers, emails and SMSes), to the extent permitted or required by law or regulation. We will not disclose your personal information to third parties except to affiliated companies and our service providers for related purposes, or as required by law.

Governing Law

24. The Terms are governed by the laws of Singapore and participants agree to submit to the exclusive jurisdiction of the courts of Singapore.

Rights of Third Parties

25. Except for Lend Lease, its subsidiaries, agents and assigns, these Terms are not intended to confer any rights on any third party under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce these Terms.
26. To the maximum extent permitted by applicable law, Jem reserves the right, in its sole discretion, to revise the rules of the Contest, or revise or cancel the Contest at any time, or to modify, terminate, or suspend the Contest should unauthorized human intervention or other causes beyond Jem's control corrupt or impair the administration, security, fairness of the entries. Jem is not responsible for any human or other error that may occur in the processing of the entries, nor responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, theft or destruction or unauthorized access to, or alternation of, entries nor for any technical, network, telephone, computer, hardware or software, malfunctions of any kind, or inaccurate transmission of, or failure to receive any entry information on account of technical problems or traffic congestion on the internet or any web site(s).
27. The Contest is in no way sponsored, endorsed or administered by, or associated with, Facebook. Any information provided in connection with the Contest will be to Lend Lease and not to Facebook.
28. In the event of any dispute, all decisions made by The Management of Jem will be final and no correspondence will be entertained thereafter.

Technical Requirements

29. Jem shall not be held liable or responsible for any delay and/or failure in the receipt of entry due to the inability of the respective Internet Service Provider [ISP] company and/or telecommunication network to provide timely and/or efficient internet and/or telecommunication services.

30. Participants also agree that the Organiser is not responsible nor liable for any delay, injury or damage to the participant's and/or any third party's computer, computer system or apparatus relating to or resulting from the access to, participation in this Contest, including the playing, downloading of any materials or information from the Love The Look App and in connection with this Contest, submission/uploading of the information/time score for this Contest, including without limitation any server failure, lost, delayed or corrupted data or other malfunction.

Jem is also not responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction, unauthorised access to, or alteration of, user or member communications, or any problems or technical malfunction of any telecommunication network or lines, computer online systems, servers or providers, computer equipment, software, failure of e-mail on account of technical problems or traffic congestion on the Internet and/or telecommunication networks.
