

## Good Eats And Art Treats (“Promotion”)

### Terms & Conditions

#### 1. Weekday Lunch E-Deals LENLEASE PLUS MEMBER EXCLUSIVE

1 September 2023 onwards

- a) Lendlease Plus Members are eligible to redeem retailers’ E-Vouchers on the Lendlease Plus mobile app, “Rewards” section during the campaign period.
- b) Retailers’ E-Vouchers will be released at 12pm on the 1st day of every month.
- c) E-Vouchers are usable only at Jem outlets within Monday – Fridays (excluding public holidays), 11am – 2pm. Detailed terms and conditions stated on respective E-Vouchers apply.
- d) All redemptions are available on a first-come, first-served basis and while stocks last.
- e) Redemption is limited to a maximum of three (3) E-Vouchers per member per voucher type throughout the promotion period and limited to usage of maximum one (1) E-Voucher per transaction, unless otherwise stated.
- f) To utilise the E-Voucher(s), members must present the unique QR code of the redeemed E-Voucher in their Lendlease Plus mobile in-app wallet to the shop staff prior to payment for scanning using the JeriPay terminal.
- g) The purchase value offset using the E-Voucher(s) will not be included in meeting the qualifying nett spend for Lendlease Plus\$ and/or voucher redemptions.
- h) All E-Vouchers are valid for use within thirty (30) days from date of redemption. Any requests for extension of validity or refund of the Plus\$ will not be entertained.

#### 2. Sip & Paint LENLEASE PLUS MEMBER EXCLUSIVE

1 – 10 September 2023 (both dates inclusive), 11.30am – 9pm, L3 (outside IKEA Jurong)

- a) Lendlease Plus Members who have accumulated minimum nett spend will be eligible to:

- b) Lendlease Plus Members with receipts from FairPrice Xtra require double spending for redemption.

- c) Limited to the first 55 redemptions per day, on a first-come first-served basis, while stocks last.
- d) The receipts used for Tier 1 redemptions cannot be utilised for Tier 2 redemptions, and vice versa. Limited to one (1) redemption per Lendlease Plus Member per day. Members are eligible to redeem either Tier 1 or Tier 2 within the same day.

- j) This is a free and easy and unguided art jamming workshop. Each participant will be provided with 1 canvas board (60cm x 50cm), acrylic paints and painting kits. Participants are required to prepare own image references for inspiration.
- k) Guidelines at the art jamming workshop:
  - i. Running is not permitted within the activity zone.
  - ii. Please handle paint with care to prevent any spillage onto the ground.
  - iii. Kindly refrain from littering in the activity area, and remember to clear your rubbish before leaving.
  - i. Your behaviour should not negatively impact the enjoyment and participation of other participants in the event, as determined by the management.
  - iv. Each participant is given maximum of 1.5 hours to complete the art jamming session.
  - v. Provided tools are meant for sharing and should only be used during the activity. After using, participants are required to return the painting tools to the designated tool rack.
  - vi. No carrier will be provided upon completion of art jamming session.
- l) By entering the art jamming workshop area, you consent that any images, audio (including voices) and video footages, interviews, and/or likeness taken may be used by Jem Management for publicity and/or marketing purposes.
- m) To utilise the complimentary beverage E-Voucher, members are required to present their unique in-app Lendlease Plus membership QR at Paris Baguette Jem cashier counter prior order. Outlet is required to scan the E-Voucher using the JeriPay terminal.

### 3. Double The Delights LENDLEASE PLUS MEMBER EXCLUSIVE

- a) Lendlease Plus Members are eligible to earn 2X Plus\$ with a minimum nett spend of S\$10 (“Qualifying Spend”) in a single receipt at participating F&B outlets of Jem.
- b) 2X Plus\$ will be calculated based on 1X base Plus\$ and 1X bonus Plus\$.
- c) This promotion is only applicable for purchases made from F&B outlets listed on <https://lendleasemalls.com/jemfnb>. For IKEA Jurong, only food and beverage purchases from the food hall are eligible for the redemption.
- d) All redemptions, whether over-desk or in-app, must be made on the same day as spend. Redemptions are on a first-come, first-served basis, while stocks last.

### 4. Shop with Citi Mastercard® CITI MASTERCARD CARD MEMBER EXCLUSIVE

1 September – 29 October 2023 (both dates inclusive), L3 Concierge Desk

- b) Citi Mastercard Cardmembers who charge a minimum nett spend of S\$120 (“Qualifying Spend”) at Jem, from 1 September to 29 October 2023, are eligible to redeem a S\$10 Lendlease voucher. - c) Members with receipts from FairPrice Xtra require double spending for redemption.
- d) Bonus Plus\$ will be credited to member's in-app wallet upon approval of qualifying receipts.
- e) Promo code is limited to the first 500 new and eligible sign-ups.
- f) Limited to 1 redemption per new member during the Promotion Period.
