2. By participating in the Contest, the participants agree to be bound by the terms and conditions ("**Terms**") of the Contest set out below. The Management reserves the right to change any of the Terms (including but not limited to the dates of the Contest and the prizes or their value) at its sole discretion without notice.
3. Except as other specified in these Terms, the participants agree that the decision of The Management on all matters relating to the Contest is final, conclusive and binding on all participants and no correspondence will be entertained.

The Contest

The Management has organised the Facebook Contest named "A Wish For Our Nation" from 7 August – 10 August 2020 (both dates inclusive) ("**Contest Period**"). Participants will have to like @JemSingapore on Facebook and share their birthday wishes for Singapore.

4. Each participant shall send his answer by way of an entry as a comment on the Facebook contest post.

One (1) contest post will be posted on <https://www.facebook.com/JemSingapore/> at 12pm on 7 August 2020.

To join, simply send answer by way of an entry as a comment via the Facebook comments box before the cut-off date/time at 11.59pm on 10 August 2020.

5. The official time is Singapore Facebook time. Any entry posted after the cut-off time will not be considered.
6. A maximum of one (1) entry per participant per Facebook account is allowed throughout the Contest Period. Where a participant submits two (2) or more entries, the last submission will be accepted as the entry from such participant's Facebook account and the rest of the entries will be void.
7. At the end of each round, a total of five (5) winners from entries submitted will be selected based on the eligibility, adherence to the Contest Terms & Conditions, and the creativity of the post at the discretion of The Management.

15. The Management reserves the right to verify the validity of all entries and the right to disqualify any participant or entrant:
 - a. who tampers with the submission or voting process;
 - b. who submits an entry that is not in accordance with these terms and conditions;



- c. who has, in the opinion of The Management, engaged in any unlawful or other improper conduct which jeopardises, or may jeopardise, the fair and proper conduct of the competition; and/or
 - d. who has engaged in conduct in entering the competition which is unlawful, fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the competition and/or The Management; and/or
 - e. any conduct or behaviour which The Management considers undesirable, improper or inappropriate.
16. Eligibility to Enter

22. Personal information of participants provided in registering for the Contest, or otherwise in other dealings with The Management, may be collected and used for the following purposes to the extent permitted or required by law:



- a. verifying your identity;
- b. announcements and important updates;
- c. sending you marketing information about our goods and services, including notifying you of our marketing events, initiatives and promotions, lucky draws, membership and rewards schemes and other promotions; and
- d. transmitting to affiliated companies, third party service providers for related purposes.

Governing Law

23. The Terms are governed by the laws of Singapore and participants agree to submit to the exclusive jurisdiction of the courts of Singapore.

Rights of Third Parties

24. Except for The Management, the Lendlease group of companies, its subsidiaries, affiliates, associates, agents and assigns, the Terms are not intended to confer any rights on any third party under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce these Terms.
25. To the maximum extent permitted by applicable law, The Management reserves the right, in its sole discretion, to revise the Terms of the Contest, or revise or cancel the Contest at any time, or to modify, terminate, or suspend the Contest should unauthorized human intervention or other causes beyond The Management's control corrupt or impair the administration, security, and fairness of the entries or for whatsoever reason The Management thinks fit. The Management is not responsible for any human or other error that may occur in the processing of the entries, nor responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, theft or destruction or unauthorized access to, or alternation of, entries nor for any technical, network, telephone, computer, hardware or software, malfunctions of any kind, or inaccurate transmission of, or failure to receive any TERMS AND CONDITIONS / entry information on account of technical problems or traffic congestion on the internet or any web site(s).
