



**“Game On. No Dragons, No Drama, Just Deals Fit For The Throne.” (Promotion)**

*31 May – 7 July 2019*

**1. Bag Your Bounty**

*31 May – 7 July 2019 (both dates inclusive)*

- 1.1 Shoppers who spend a minimum of **S\$180 (S\$150 for Lendlease Plus members)** at any Stores, within a maximum of three (3) same-day receipts, from 31 May – 7 July 2019, are eligible to redeem an exclusive Jem dual-use tote bag and a \$5 Lendlease gift voucher.
- 1.2 Gift redemption is limited to the first **150** shoppers only per day. Redemption is on a first-come first-served basis, while stocks last.
- 1.3 Shoppers with receipts from FairPrice Xtra require double spending for redemption.

### 3. Archers Assemble!

- 3.3 Redemption is limited to the first **100** shoppers per day. Redemption is on a first-come first-served basis, while stocks last.
- 3.4 Shoppers with receipts from FairPrice Xtra require double spending for redemption.
- 3.5 This redemption is **exclusive** from other gift-with-purchase promotions / events running from 7 – 9, 14 – 16, 21 - 23 June 2019. Receipts can only be used once for redemption of the Archers Assemble and cannot be used again to redeem any other gift-with-purchase promotions / events available from 7 – 9, 14 – 16, 21 - 23 June 2019.
- 3.6 Redemption must be made on the same day as purchase. Limited to one (1) redemption per shopper per day.
- 3.7 Shoppers must be physically present at the time of redemption and must show an original proof of purchase to be eligible for the redemption.

- iv. In meeting the minimum spend requirement, persons are NOT allowed to use prepaid cards, as a form of top-up.
