



## Ready, Get Set, Shop! Terms & Conditions

### 1. \$3 Off Your Grab Rides!

9 September – 31 October 2020

- 1.1 Shoppers are eligible to enjoy \$3 off their GRAB ride to Lendlease Malls from 9 September – 31 October 2020.
- 1.2 Promo codes are available on a first-come, first-served basis and while stocks last.
- 1.3 Shoppers must download the latest version of the Grab mobile app in order to enjoy the Grab Promo Code.
- 1.4 Promo codes are only valid for all fleets except for Grabhitch and Grabshuttle to Lendlease Malls, where drop off locations must comprise the corresponding postal codes as follows:

- 1.5 All bookings must be made using the Grab mobile app. Drop-offs have to be at the respective malls as destination.
- 1.6 Limited to a maximum of three (3) redemptions per Grab user throughout the promotion period.
- 1.7 If the shopper cancels a ride booked with the promo code, it will be considered as a successful redemption.
- 1.8 Grab Promo Code is not exchangeable for cash and only valid on Singapore registered mobile numbers used in the Grab mobile app.
- 1.9 The promo codes are valid for use from 9 September – 31 October 2020. Request for extension of promo codes will not be entertained.
- 1.10 Utilisation of promo codes remain subjected to the standard Grab's Terms and Conditions.

## 2. \$5 Off Your foodpanda Orders!

9 September – 31 October 2020

- 2.1 Shoppers are eligible to enjoy \$5 off (\$5 foodpanda promo code) with a minimum order of \$15 on foodpanda from 9 September – 31 October 2020.
- 2.2 Promo codes are limited to first 1,740 redemptions per mall and are available on a first-come, first-served basis, while stocks last.
- 2.3 Participating F&B tenants must be a valid tenant in the respective Lendlease Malls, and their listing on foodpanda must comprise the corresponding postal codes as follows:

- 3.2 Limited to 1 redemption per mall per day regardless of total amount spent. All redemptions are available on a first-come, first-served basis and while stocks last.
- 3.3 Only receipts used for the voucher redemption shall be entitled to the fast track points. Fast track points will only be rewarded to shoppers who have successfully redeemed the voucher. A minimum of \$10 per receipt is required to earn Lendlease Plus\$.
- 3.4 Redemption can be at any Lendlease malls in order to be eligible for the next tier of the \$10 Lendlease voucher + 2X Plus\$ or 3X Plus\$ from 9 September – 31 October 2020.

4.5 To utilise the E-deal, the member must present the unique QR code on E-deal to the Retailer shop staff prior to payment for scanning using the JeriPay terminal.

4.6 All E-deals are valid for use within three (3) months from date of redemption, unless otherwise stated, and at the locations stated within the respective E-deal only. Any requests for extension of validity will not be entertained.

4.7 All E-deals are not applicable for use in conjunction with other promotions and vouchers, unless otherwise stated.

4.8 E-deals cannot be used for purchase of vouchers/ gift cards.

4.9 All E-deals are strictly non-refundable, non-exchangeable for physical vouchers once redeemed.

4.10 All Plus\$ used to redeem the E-deal(s) are strictly non-refundable once redeemed.

4.11 All other standard terms and conditions of the Lendlease Plus Programme apply.
